SPI's bid to purchase 16-hectare land in Entertainment City

**Background/Description of the Disclosure**

Sureste Properties Inc. (SPI) a wholly owned subsidiary of Bloomberry Resorts Corporation (BRC) submitted today a bid to purchase the 16 hectares land in Entertainment City where Solaire Resort & Casino (Solaire) and its expansion area is located. The bidding is conducted by the Philippine Amusement and Gaming Corporation (PAGCOR) as owner of the land. SPI, the owner and operator of the hotel and non-gaming facilities in Solaire, is the lessee of the subject land.

SPI also submitted to PAGCOR an offer to purchase the subject land by negotiated sale, in the event the bidding will fail. The first bidding conducted by PAGCOR to sell the land on 1 December 2017 failed because no bidder submitted a bid.
