Bloomberry Announces Intent to Broaden Investment Universe

Background/Description of the Disclosure

Bloomberry Resorts Corporation (“Bloomberry,” “the Company”) announces its intent to make additional future investments in the interest of enhancing shareholder value.

Bloomberry’s future investments will be considered within a broader universe of possible opportunities which include gaming, hospitality, and other non-gaming assets. The Company will consider various opportunities in light of their potential to create additional value for shareholders.

At this time, the Company does not have any particular investments or acquisitions that are under imminent consideration and therefore will not make any investment-related announcements in the near-term.

Bloomberry is currently constructing Solaire North which will be its second Integrated Resort in the Philippines. Solaire North is located in the populous and highly urbanized Quezon City.

At the Company’s flagship property, Solaire Resort & Casino, the gaming floor has been closed since March 16, 2020 according to PAGCOR’s instructions and in compliance with the Philippine Government’s Enhanced Community Quarantine initiative.

About Bloomberry Resorts Corporation

Bloomberry (PSE: BLOOM) is a public company listed on the Philippine Stock Exchange that develops destination resorts featuring premium accommodations, gaming and entertainment, and world-class restaurants and other amenities. Bloomberry Resorts Corporation’s subsidiaries own and operate the Solaire Resort & Casino in the Philippines and Jeju Sun Hotel & Casino in Korea.

Bloomberry’s primary purpose is to subscribe, acquire, hold, sell, assign or dispose of shares of stock and other securities of any corporation, including those engaged in hotel and/or gaming and entertainment business or in the business of an investment company, to the extent permitted by law, and to be involved in the management and operations of such investee companies; and to guarantee the obligations of its subsidiaries or affiliates or any entity in which Bloomberry has lawful interest.
