#### Clarification of News Report

We write in connection with your letter to Bloomberry Resorts Corporation (the "Company") dated April 24, 2020 seeking clarification and/or confirmation relating to the news article entitled "ICTSI cuts spending budget due to COVID" posted in philstar.com. The article reported in part that:

" . . . .

For his casino business, Razon said Bloomberry may report a loss, . . .

. . . ."

The Company confirms the statement of Mr. Razon above and would like to clarify that such loss is possible due to the suspension of casino operations of BLOOM in compliance with the order of PAGCOR and due to the Enhanced Community Quarantine (ECQ) in Metro Manila. The ECQ in Metro Manila, which has just been extended to 15 May 2020, is intended to prevent the spread of the virus which causes the COVID-19 disease. Another reason is the severe contraction of businesses worldwide caused by the lockdown imposed by most countries around the world which mean lower travel and lower priority for leisure activities. Management is currently preparing for the eventual restart of operations and is designing stringent cleanliness and social distancing protocols that are appropriate for an entertainment venue like Solaire.
