Subject of the Disclosure

Update to the Disclosure dated 26 January 2018 on SPI's bid to purchase 16-hectare land in Entertainment City

Background/Description of the Disclosure

Sureste Properties Inc. (SPI), a wholly owned subsidiary of Bloomberry Resorts Corporation (BLOOM), received today a Notice of Award from the Philippine Amusement and Gaming Corporation (PAGCOR), awarding to SPI the purchase of the 16 hectares land in Entertainment City where Solaire Resort & Casino and its expansion area is located. The purchase price is P 37,333,130,000 as approved by the PAGCOR Board on 18 April 2018. SPI was the sole offeror for the property in a negotiated sale after two failed biddings. The purchase price is P 100 Million above the floor price set by PAGCOR for the property. SPI will complete the transaction, sign the Deed of Absolute Sale and pay the balance of the purchase price within 45 days.
