#### Background/Description of the Disclosure

Bloomberry Resorts & Hotels Inc. (BRHI) as borrower and mortgagor and Sureste Properties Inc. (SPI) as mortgagor, pledgor and surety, signed a P 73.5 Billion syndicated loan with a syndicate of banks yesterday, 10 April 2018. SPI and BRHI are subsidiary companies of Bloomberry Resorts Corporation (BLOOM). The syndicate of banks is composed of BDO Unibank Inc., BDO Private Bank, Inc., China Banking Corporation, Philippine National Bank, PNB Savings Bank, Robinsons Bank Corporation and United Coconut Planters Bank.

BDO Capital & Investment Corporation was the lead arranger and sole book runner, China Bank Capital Corporation was the Co-Arranger, and BDO Unibank Inc. - Trust and Investments Group was the security trustee, facility agent and paying agent of the loan.

The loan refinanced all the existing loans of BRHI and SPI. Part of the proceeds will be used for investments and working capital requirements of BRHI.
