Clarification of News Report

We write in connection with your letter to Bloomberry Resorts Corporation (the "Corporation") dated 11 June 2015 seeking clarification and/or confirmation relating to the news article entitled "Bloomberry on expansion mode for casino business" published in the June 11, 2015 issue of The Philippine Star. The article reported in part that:

"Bloomberry Resorts Corp. of port magnate Enrique Razon Jr. is pursuing the expansion of its casino business abroad as it sets its sights on countries such as Taiwan and Japan, as well as in South America.

In an interview on the sidelines of the company's annual stockholders meeting yesterday, Razon said Bloomberry is interested to bring its integrated resort casino operations to Taiwan should the country legalize gaming.

Japan is also on the company's list given its potential. Lawmakers from Japan are currently looking to legitimize gambling in the country, said Razon.

. . . .

But while Bloomberry waits for the legalization of gaming in Japan and possibly Taiwan, the company has a closer shot at South America, he added.

. . .

Razon said funding for its Korea venture would be a combination of local resources and financing in Korea.

. . . ."

Taiwan, Japan and South America are just some of several prospective jurisdictions outside the Philippines that Bloomberry is looking at, but there is nothing definitive at this point. It is part of the company's ordinary course of business to continuously evaluate potential opportunities offshore.

We will make the proper disclosure when a definitive agreement is reached in any of these offshore projects.
