Clarification of News Report

We write in connection with your letter to Bloomberry Resorts Corporation (the "Corporation") dated 21 September 2015 seeking clarification and/or confirmation relating to the news article entitled "Razon tangos to Argentina for 2nd overseas casino" published in the 21 September 2015 issue of The Philippine Star. The article reported in part that:

"Solaire has yet to open its first overseas branch in South Korea, but Enrique Razon Jr. has already jumped over the Pacific to prepare his casino resort's second overseas branch, all the way to Argentina.

According to regulatory records, Solaire's listed parent Bloomberry Resorts has established another subsidiary, Solaire de Argentina SA, and appointed the head of the country's hotel association, Oscar Alberto Ghezzi of the Federacion Empresaria Hotelera Gastronomica de la Republica Argentina, as president of the venture.

The Argentinian subsidiary has already built a work-related website, www.solairedeargentina.com, even though the company, according to the grapevine, has yet to secure the regulatory approvals for a hotel-casino site in an undisclosed area in the capital Buenos Aires.

Solaire de Argentina S.A. is an Argentine company that is 94% owned by Bloomberry Resorts Corporation held through Bloom Capital B.V., a 100% Netherlands subsidiary of Bloomberry Resorts Corporation. These subsidiaries were duly disclosed and appear in the annual report and other reports of Bloomberry Resorts Corporation.

Solaire de Argentina has a proposal to establish an integrated resort in Argentina, but it is still pending evaluation and action of government agencies and regulators in Argentina.

Oscar Alberto Ghezzi is the president of Solaire de Argentina S.A. He was past president of the Federacion Empresaria Hoteleria Gastronomica de la Republica Argentina. He is the current president of Camara Argentina de Turismo.

Solaire de Argentina S.A. has a work-related website that it currently uses for internal communications.
