Clarification of News Report

We write in connection with your letter to Bloomberry Resorts Corporation ("BLOOM") dated March 31, 2021 seeking clarification and/or confirmation relating to the news article entitled "Billionaire Razon sued for ending Manila casino deal" posted in BusinessWorld (Online Edition) on March 30, 2021. The article reported in part that:

"Philippines billionaire Enrique Razon was sued in New York by a company that claims the tycoon illegally terminated an agreement to operate a Manila casino and is hiding assets in the U.S. to avoid paying an arbitration award.

The suit, filed Monday in federal court in New York by Global Gaming Philippines, seeks to confirm a \$296.6 million arbitration award handed down by a panel in Singapore against Razon over his withdrawal of rights to operate the Solaire Resort and Casino in Manila's Entertainment City suburb.

BLOOM confirms that news report.

GGAM has sued Enrique K. Razon Jr. (and several companies associated with him) in the U.S. District Court in the Southern District of New York. The suit is to enforce an arbitral award against two Philippine companies (Bloomberry Resorts & Hotels Inc. and Sureste Properties Inc.) owned by Bloomberry Resorts Corporation (BLOOM). BLOOM is a company whose shares are listed in the Philippine Stock Exchange (PSE). Even now the enforcement of that arbitral award is on appeal in the Singapore Court of Appeals. This is in addition to a court case in the Regional Trial Court (RTC) of Makati City, Philippines which issued a writ of attachment and writ of preliminary injunction against the shares in BLOOM that GGAM was trying to sell while arbitration was pending. GGAM's action to lift the attachment and injunction issued by the RTC is even now pending in the Philippine Supreme Court.

GGAM has previously dragged Mr. Razon in a suit in Hong Kong against Deutsche Bank to compel the release of the shares in BLOOM subject of the RTC attachment and injunction. GGAM had to ask the Hong Kong court to suspend the proceedings because of the subsisting Philippine court actions. GGAM had to pay the cost of Mr. Razon as the Hong Kong court considered GGAM's implicating Mr. Razon there unwarranted.

Mr. Razon (and the companies associated with him) will vigorously oppose this shameless GGAM forum shopping and attempt to enforce an arbitral award against those who are not a party to the arbitration.
