#### Nature and description of the legal proceedings

Further to its disclosures to the Philippine Stock Exchange dated 6 January 2020, 29 May 2020, and 16 February 2021, Bloomberry Resorts Corporation (BLOOM) hereby discloses that its subsidiaries Sureste Properties Inc. (SPI) and Bloomberry Resorts and Hotels Inc. (BRHI) received today the Judgment of the Singapore Court of Appeal dismissing their appeal against the decision of the Singapore High Court dated 29 May 2020 which denied their petition to set aside the Final Award of the Arbitration Tribunal in favor of GGAM.

In the event that GGAM will file an action to enforce the Arbitral Award in the Philippines where the assets and business of BRHI and SPI are located, BRHI and SPI will oppose such enforcement based on applicable Philippine law.
