Background/Description of the Disclosure

In compliance with the Notice issued by the Securities and Exchange Commission on March 12, 2020 to Publicly Listed Companies on the Subject of Filing of Current Report under Section 17 of the Securities and Regulation Code amid COVID-19 Pandemic, BLOOM hereby discloses that:

On January 31, 2020, the World Health Organization ("WHO") declared the novel coronavirus acute respiratory disease (2019-nCoV ARD now COVID-19) health event as a public health emergency of international concern after an emergency committee convened on January 30, 2020 in Geneva, Switzerland. On the same day, the Philippines issued a temporary travel ban covering all travelers coming from Hubei Province of China. On February 2, 2020, the Philippines banned all travel to and from China and its two administrative regions, Hong Kong and Macau, to stem the spread of COVID-19. On March 11, 2020, the WHO characterized COVID-19 as a pandemic. On March 12, 2020, Philippine authorities placed Metro Manila under community quarantine, prohibiting land, domestic air, and domestic sea travel to and from Metro Manila for a month from March 15 until April 14, 2020. As of March 15, 2020, the Philippines has 140 confirmed cases of COVID-19.

The travel bans and risk of COVID-19 infection will reduce and adversely affect the volume of people coming to the Philippines and Metro Manila from China and other countries or areas which in turn will adversely affect the business of BLOOM. In order to mitigate the risks and effects of COVID-19 on its business, BLOOM has implemented the following health and safety measures at Solaire Resort and Casino ("Solaire"):

- State-of-the-art temperature scanners have been installed at all entry points of its property for both guests and team members.
- Multiple hand sanitizer dispensers have been installed in all public areas and back offices.
- Face masks have been provided especially for frontline employees.
- A medical clinic is on standby with additional medical personnel to properly provide assistance for COVID-19 related incidents.
- More meticulous measures have been taken in sanitizing and maintaining cleanliness in all areas of its property.
- A mandatory 14-day self-quarantine has been imposed for all team members who have traveled abroad.
- All personnel have been required to make it a habit to consistently and thoroughly wash their hands with soap, alcohol or hand sanitizers, and maintain excellent hygiene.

In addition, BLOOM will comply with PAGCOR's instruction dated March 15, 2020 which states:

"PAGCOR suspends casino operations and other gaming activities
March 15, 2020

"In line with the instruction of President Rodrigo R. Duterte to put Metro Manila under community quarantine to prevent the further spread of the Novel Coronal Virus Disease-2019 (COVID-19), the Philippine Amusement and Gaming Corporation (PAGCOR) is suspending all gaming operations effective immediately.

"The suspension applies to land-based casinos (both PAGCOR-owned and operated as well as licensed and integrated resort-casinos), electronic game (eGames), bingo (traditional and electronic), sports betting, poker, and slot machine clubs, and other activities regulated by PAGCOR, and will last for the duration of the National Capital Region (NCR) community quarantine imposed by the government.

"In accordance with Executive Secretary Salvador Medialdea's directive, restaurants and food outlets within the gaming areas may remain open. Hotels where the casinos and gaming facilities are housed may continue to accommodate guests, but are discouraged from hosting large functions and events.

"PAGCOR believes in the seriousness of the COVID-19 situation. Hence, it supports the government's extreme effort in containing the virus. For its part, the state-run gaming agency has decided to prohibit gatherings in its gaming venues and in the licensed gaming properties that it regulates."
